International Industry

- ARSA worldwide membership
 - 20 countries on five continents
- Contract maintenance expanding globally
 - Projected growth of 4.2% annually until 2024
- International environment must foster growth
 - Free from unnecessary micromanagement
 - Encourages cooperation between civil aviation authorities (CAAs)
 - Respects international sovereignty



Legislative History

- Proposal originated from push by labor unions precipitating false safety and economic arguments
- Real motivation=hindering contract maintenance
- FAA reauthorization proposals dating back to 2008 included provisions that were much worse
- ARSA, industry allies successfully "moderated" drug & alcohol testing language in FAA Modernization & Reform Act
- "Consistent with the applicable laws of the country in which the repair station is located"

ARSA Activities

- Filed request for extension—FAA granted 60 days
- Coordinating coalition activities
- Raising visibility of the issue through industry publications and outreach
- Conducting research and collecting information to support ARSA comments
 - Identified 64 countries with FAA-certificated repair facilities (see if there is a facility located in your country at http://av-info.faa.gov/repairstation.asp)
 - Sent survey to contacts at 695 companies at foreign FAA-certificated repair facilities



Industry Survey

- Available at <u>www.surveygizmo.com/s3/1635615/FAA-</u> <u>Drug-and-Alcohol-Testing</u>
- Survey sent to FAA-certificated part 145 repair stations operating outside the U.S. and Canada
- Collects information regarding drug & alcohol laws in the respondent's country, whether testing is mandated, permitted or prohibited and the company's current testing practices



Preliminary Results

- Received 17 complete responses representing repair stations in 10 countries including Argentina, China, Jordan, Malaysia, Mexico, Netherlands, Singapore, South Africa, Sweden and the United Kingdom
- According to respondents, of the 10 countries represented, 3 mandate drug and alcohol testing, 6 permit it and 1 prohibits it
- Ninety-one percent of respondents in countries that permit, but do not require drug and alcohol testing, do *not* have a screening program in place



Action Items

- Circulate survey to maintenance providers in your country
- Continue dialogue with ARSA (use each other as resources)
- Contact your counterpart who can determine what the drug and alcohol testing laws are in your country
