Part [43](#) Maintenance, Preventive Maintenance, Rebuilding, and Alteration. **Level 1** For anyone working in aviation

§ [43.9](#) Content, form, and disposition of maintenance, preventive maintenance, rebuilding, and alteration records (except inspections performed in accordance with part [91](#), part [125](#), § [135.411\(a\)\(1\)](#), and § [135.419](#) of this chapter).

- (a) *Maintenance record entries.* Except as provided in paragraphs (b) and (c) of this section, each person who maintains, performs preventive maintenance, rebuilds, or alters an aircraft, airframe, aircraft engine, propeller, appliance, or component part shall make an entry in the maintenance record of that equipment containing the following information:
 - (1) A description (or reference to data acceptable to the Administrator) of work performed.
 - (2) The date of completion of the work performed.
 - (3) The name of the person performing the work if other than the person specified in paragraph (a)(4) of this section.
 - (4) If the work performed on the aircraft, airframe, aircraft engine, propeller, appliance, or component part has been performed satisfactorily, the signature, certificate number, and kind of certificate held by the person approving the work. The signature constitutes the approval for return to service only for the work performed.
- (b) Each holder of an air carrier operating certificate or an operating certificate issued under Part [121](#) or [135](#), that is required by its approved operations specifications to provide for a continuous airworthiness maintenance program, shall make a record of the maintenance, preventive maintenance, rebuilding, and alteration, on aircraft, airframes, aircraft engines, propellers, appliances, or component parts which it operates in accordance with the applicable provisions of Part [121](#) or [135](#) of this chapter, as appropriate.
- (c) This section does not apply to persons performing inspections in accordance with part [91](#), [125](#), § [135.411\(a\)\(1\)](#), or § [135.419](#) of this chapter.
- (d) In addition to the entry required by paragraph (a) of this section, major repairs and major alterations shall be entered on a form, and the form disposed of, in the manner prescribed in appendix [B](#), by the person performing the work.

B: **False. Maintenance records for major repairs and alterations must comply with both § [43.9\(a\)](#) and [appendix B](#)-Recording of Major Repairs and Major Alterations.**

Question 3: Maintenance records must include:

- A: The name of the persons who performed the work and a description of the work or reference to data acceptable to the Administrator.
B: The signature, certificate number and type of the person approving the work for return to service.
C: The date the work was completed.

D: All of the above; review § [43.9\(a\)](#) carefully.

Question 4: The person who signs the maintenance record is certifying that:

- A: The article (which can be an aircraft) is airworthy.
B: The article (which can include an aircraft) is being returned to service.
C: **The signature certifies “only the work performed” as being approved for return to service: § [43.9\(a\)\(4\)](#). Maintenance actions do not return anything to service, that is an operational obligation. Maintenance persons only certify the nature and extent of the work performed and recorded.**
D: A part [91](#) inspection was performed. **This section specifically excludes inspections.**
