## **Model Repair Station Quality Manual Compilation Licensing Agreement**

### **5. Term**

This License is effective until terminated. User may terminate the License at any time by destroying all electronic and printed copies of the Compilation and any derivative works in User's possession and notifying ARSA. The License will also terminate upon conditions set forth elsewhere in this document or if User fails to comply with any term

or condition. If ARSA terminates this License, User agrees upon the termination to destroy all electronic and printed copies of the Compilation and any derivative works in User's possession. Sections 2, 6, and 7 of this License will survive any termination.

Any award rendered pursuant to such arbitration may be entered and enforced in any court of competent jurisdiction.
